### **NEW FEES**

Effective June 15, 2015 the following new health service codes will be available for billing for services on or after June 15, 2015. 	<b>Billing Guidelines</b> Can be billed with 03.04, comprehensive office visit, same service date for Return to Work Services.	
	Can be billed as Long Term Benefits (LTB) Follow-up Report. Only required if there is a change in medical status or treatment. Not required for changes in medication. Can be billed with 03.03 or 03.03A office visit, same service date.

WCB27	Eye Report	\$56.25
	Billing Guidelines Only to be used on request of the WCB. Can be billed with an office visit, if needed, same service date.
