Due to implementation of a new shingles immunization program for individuals 65+, the following service is effective May 28, 2025:

INTERIM FEE UPDATE

Effective May 23, 2025 the guidelines for TPR1 have been clarified:

DEFT	TPR1	Telephone Prescription Renewal	4 MSU
		 Description This service is billable by a family physician when the physician is requested by a patient to communicate a prescription renewal by telephone, fax, or email with no requirement to see the patient for an in-person visit. Billing Guidelines Documentation on the patient's chart must indicate that this service was initiated at the patients request. The drug, dose, and amount prescribed must be documented. These can be done in the form of a visit note and must be retrievable upon request. This HSC is not to be billed for writing new prescriptions. This HSC may not be billed if the physician bills a visit with the patient (face to face or virtually) on the same day. May not be billed more than 4 times per year per patient per provider.

Billing Matters Billing Reminders, Updates, New Explanatory Codes

LONG TERM CARE CGA1 REMINDER

Physicians are reminded when billing for the LTC CGA, the CGA requires one direct service encounter with the resident by the physician on the date of the final completion and signing of the CGA form. Prior to claiming the CGA fee, the physician must review, complete, and sign the CGA form in the long-term care facility on the date of the final CGA service encounter and place a note in the resident's clinical record (progress notes) corroborating that the CGA has been completed.
